As of 2000, Worcester had a population of 888, comprised completely of rural residents. The population has decreased by 2% since 1990. Worcester contains more females than males. Approximately 51% of the total population is female, while 49% is male. Table A. shows the breakdown of age groups amongst the total population in Worcester. Approximately 25% of the population is children, age 18 and under, while 6% of the population is senior citizens, age 65 and over. The number of residents age 18 and under and age 65 and over has decreased throughout the last decade. There are currently 19.4% less children and 12.3% less senior citizens in Worcester than there were in 1990.

Of the total population in Worcester, 100% live in households. Of these people, 85% live in family households, while 15% live in nonfamily households. Of the 353 total households in Worcester, 71% are family households, while 29% are nonfamily households. Most of the family households contain 2 to 4 persons. Approximately 47% are 2-person households, while 22% are 3-person households, and 22% are 4-person households. Most of the nonfamily households contain 1 or 2 persons. Approximately 75% are 1-person households and 21% are 2-person households. Compared to 1990, there are currently 8.9% more households in Worcester. Of the 252 total families that reside in Worcester, approximately 83% are married-couple families. Of these married-couple families, 38% have children under the age of 18, while 62% do not have children under the age of 18. The remaining 17% of families in Worcester fall under the category of other family. See Table C. for details. Approximately 68% of these families have a female householder with no husband present, while 32% have a male householder with no wife present. In total, there are 5.9% more families residing in Worcester than there were in 1990.

In Worcester, there are 495 workers age 16 and over, which is a 23.1% increase from 1990. Approximately 17% of these workers work in Worcester, while 83% work outside

of the community. The majority of workers, 91%, travel to work by car, truck, van, or motorcycle. Approximately 81% of those who travel to work by car, truck, van, or motorcycle drive alone, while 19% use carpools. See Table D. for other means of transportation used by workers in Worcester. Although there are a range of travel times for Worcester workers, 17% commute between 5 and 19 minutes. Approximately 57% commute between 20 and 39 minutes. Only 3% travel less than 5 minutes to work, while 1% travel more than 90 minutes to work from Worcester.

In Worcester, there were 228 people attending school at some level in 2000, which is a 12% decrease from 1990. A range of educational attainment is represented by the population in Worcester. Only 0.3% of all residents 25 years and older have not completed any level of schooling, while 30% have only a high school diploma. Approximately 40% of Worcester residents 25 years and older hold some type of degree, ranging from an Associates degree to a Doctorate degree. See Table E. for details.

In Worcester, there are 535 residents in the labor force, which is 76% of the population age 16 and over. This is a 16.8% increase from 1990. Approximately 96% of the people in the civilian labor force are employed, while 4% are unemployed. The 22 residents that are unemployed represent 54.2% less than the unemployment level in 1990. All of the industries covered in the Census are represented by residents of Worcester. The industries with the largest percentage of workers are: education, health, and social services, which represents 23.3% of employed residents; public administration, which represents 18.4% of employed residents; and manufacturing, which represents 9.6% of employed residents. Table G. shows household income and family income data for Worcester. All income classes are represented here. Approximately 2% of the total households have an income of less than \$10,000; 19% have an income between \$10,000 and \$25,000; 39% have an income between \$25,000 and \$50,000; 22% have an income between \$50,000 and \$75,000; 12% have an income between \$75,000 and \$100,000; and 6% have an income above \$100,000. In 1999, the median household income in Worcester was \$39,732, which is a 39.6% increase from 1990. Approximately 3% of the total families have an income of less than \$10,000; 17% have an income between \$10,000 and \$25,000; 31% have an income between \$25,000 and \$50,000; 25% have an income between \$50,000 and \$75,000; 15% have an income between \$75,000 and \$100,000; and 9% have an income above \$100,000. In 1999, the median family income in Worcester was \$48,750, which is a 57.7% increase from 1990. In 1999, the per capita income for Worcester was \$19,698, an 89.3% increase from 1990. Approximately 9% of people in Worcester for whom poverty status is determined have incomes below poverty level. The 75 residents who have incomes below poverty level are 3.8% less than those who suffered from poverty in 1990.

There are 400 total housing units in Worcester, all of which are located in a rural area. This is a 10.5% increase from the total housing units in 1990. Approximately 87% of these housing units are currently occupied, leaving 13% vacant. Of these vacant housing units, 4% are for rent, while 10% are for sale. Approximately 71% of the vacant housing units are for seasonal, recreational, or occasional use. There are currently 34.2% more

housing vacancies in Worcester than there were in 1990 and the occupancy level has increased by 7.7% over the last decade. See Table H. for details.

Of the 349 total occupied housing units in Worcester, 61% are 1 to 2 person households, while 32% are 3 to 4 person households. Of the 400 total housing units in the Town, most have between 4 and 8 rooms. Approximately 5% have 1 to 2 rooms; 20% have 3 to 4 rooms; 42% have 5 to 6 rooms; 24% have 7 to 8 rooms; and 9% have 9 or more rooms. Many of the housing units in Worcester were built prior to 1980. Approximately 32% of the houses were built before 1939; 40% were built between 1940 and 1979; and 29% were built after 1980. Approximately 93% of the total housing units in Worcester contain complete plumbing facilities, leaving 7% without adequate plumbing. See Table J. for details.
